



Perbadanan TAIB “New Account Opening and Debit Card Application Promotion”

Specific Terms and Conditions (“T&C”)

The following T&C applies exclusively to the “New Account Opening and Debit Card Application Promotion” (“Promotion”) held by Perbadanan TAIB, and is to be read together with the Debit Card Terms and Conditions, Digital Banking Terms and Conditions, Perbadanan TAIB General Terms and Conditions and the Debit Card Product Disclosure Sheet, which shall form part of this Specific T&C.

1. DEFINITIONS

“**Account**” refers to Al-Wadiah Savings Account, Berjasa Savings Account or current account in Perbadanan TAIB;

“**Customer(s)**” refers to an individual who has an account with Perbadanan TAIB;

“**Non-Eligible Persons**” refers to employees, Board of Directors and Members of the Syariah Advisory Committee (“SAC”) of Perbadanan TAIB’s Group of Companies’ and for Customers with existing Debit cards.

“**Perbadanan TAIB Card(s)**” refers to any of the TAIB debit cards issued by Perbadanan TAIB used by the Customer as a medium of payment for the purchase of goods or services;

“**Perbadanan TAIB Merchant**” refers to any retailer or establishment participating in TAIB Merchant Delights as listed in the following link: <https://www.taib.com.bn/taib-web//cards/MerchantDelights#/>;

“**Promotion**” refers to New Account Opening and Debit Card Application;

“**Promotion Period**” refers to the duration of the Promotion.



2. PROMOTION PERIOD

2.1. Subject to Clause 2.2 below, this Promotion shall be valid from 19th August to 18th October 2023 (“Promotion Period”).

2.2. Perbadanan TAIB, at its sole discretion, may revise the Promotion Period from time to time.

3. ELIGIBILITY & CAMPAIGN MECHANICS

3.1 This Promotion is open to new Customers whom during the Promotion Period, opens an Account and applies for Perbadanan TAIB Card with Perbadanan TAIB.

3.2 This promotion is applicable to Al-Wadiah, Berjasa and Personal Current accounts only.

3.3 Customers whose accounts have been suspended, cancelled, or terminated for whatsoever reasons during the Promotion Period shall automatically be disqualified from the Promotion.

3.4 This Promotion does not apply to Non-Eligible Persons.

4. CAMPAIGN MECHANICS

4.1 The first 1,000 Customers who are successful in opening an Account and with their debit card application during the Promotion Period are entitled to a \$5 gift voucher, in the form of either of the following upon collection of their new debit cards:

(a) \$5 TAIB Fuel Voucher.

(b) \$5 McDonalds Voucher.

5. GENERAL

5.1 By participating in this Promotion, the Participant agrees to be bound by this Specific T&C.

5.2 Perbadanan TAIB reserves the right to extend, cancel, terminate, or suspend this Promotion at any time without assigning any reasons and without prior notice.

5.3 Perbadanan TAIB reserves the right to amend, add, vary or modify any provision in this Specific T&C at any time, and such modification, amendment, variation or addition shall be notified to the Customer.

5.4 The Customers shall accept the prizes on an 'as is where is' basis.

5.5 Perbadanan TAIB shall not be liable for any failure to receive notices due to including but not limited to spam, junk, or other security settings or for any incorrect contact information.

5.6 In the event of any inconsistency between this Specific T&C and any brochure, marketing or material relating to this Promotion, this Specific T&C shall prevail.

5.7 Perbadanan TAIB's decision on any or all matters relating to this Specific T&C shall be final, conclusive, and binding and no correspondences, queries, appeals or attempts to dispute such decision shall be entertained.

5.8 By agreeing to this Specific T&C, the selected Customers hereby authorize Perbadanan TAIB and shall be entitled to use his names, pictures/photographs for publicity, advertising and/or commercial purposes.



5.9 Perbadanan TAIB may substitute prizes with similar value and at any time without prior notice and is not obliged to inform reasons thereof.

5.10 Perbadanan TAIB shall not be liable for any loss, damage or expenses arising out of or in connection with the Customer's application for Perbadanan TAIB Card under this Promotion or resulting from Perbadanan TAIB's non-performance due to natural disaster, war, riot, strike, lockout, industrial action, fire, storm, act of terrorism, technical or system failure or any event beyond Perbadanan TAIB's control.

5.11 For the avoidance of doubt, any extension, cancellation, termination or suspension of this Promotion, the Customer whose application has been approved shall not be entitled to any compensation or make any claim against Perbadanan TAIB.

5.12 This Specific T&C shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any dispute or claim arising herefrom.

5.13 This Promotion cannot be used in conjunction with other offers, promotions, and/or privileges unless otherwise stated.

5.14 The Customer is not allowed to assign any of their rights or obligations under this Promotion.
