

STP Gift and Tag Campaign Promotion

Specific Terms and Conditions (“T&C”)

The following T&C apply exclusively to the Social Media Gift and Tag Campaign Promotion (“Promotion”) held by Perbadanan TAIB, and is to be read together with the Digital Banking Terms and Conditions and Perbadanan TAIB General Terms and Conditions, which shall form part of this Specific T&C.

1. DEFINITIONS

“**Customer(s)**” refers to an individual who has an account with Perbadanan TAIB;

“**Participant**” refers to individuals who participate in the Promotion;

“**Promotion**” refers to Social Media Gift and Tag Campaign Promotion;

“**Promotion Period**” refers to the duration of the Promotion.

“**Winner**” refers to the Participant who won during the Promotion.

2. PROMOTION PERIOD

2.1. Subject to Clause 2.2 below, this Promotion shall be valid from **26th August until 1st September 2024** (“Promotion Period”).

2.2. Perbadanan TAIB, at its sole discretion, may revise the Promotion Period from time to time.

3. ELIGIBILITY & CAMPAIGN MECHANICS

3.1. This Promotion is applicable to new and existing Customers of Perbadanan TAIB.

3.2. Perbadanan TAIB employees and its subsidiaries are not eligible to participate in this Promotion.

3.3. Participant must follow Perbadanan TAIB Instagram account throughout the duration of the Promotion.

3.4. Participants of this Promotion that do not meet the eligibility criteria as set by Perbadanan TAIB from time to time may automatically be disqualified.

3.5. Participants whose social media Instagram accounts have been deactivated for whatsoever reasons during the Promotion period shall automatically be disqualified from this Promotion.

3.6. Ten (10) lucky winners will be selected for this Promotion.

3.7. Mechanism of the Promotion is as follows:

- Participant must follow Perbadanan TAIB Instagram account @taib.bn
- Like the specified Promotion post
- Tag 3 friends in the post comment

3.8 Participants shall not be charged any fees to participate in this Promotion.

3.9 Each participant is allowed for multiple entries; however, lucky Participant will only be acknowledged as a Winner once.

3.10 The Winner will be selected by a random drawing selection under the supervision of Perbadanan TAIB.

3.11 The Winner will be notified via social media direct message within five (5) days following the selection of Winner.

3.12 Perbadanan TAIB shall have no liability for the Winner's failure to receive notices due to spam, junk, or other security settings or for the Winner's provision of incorrect or otherwise non-functioning contact information.

3.13 In the event of the Winner could not be contacted or fails to respond to Perbadanan TAIB within 72 hours from the time the award notification was sent, the prize may be forfeited, and an alternate Winner shall be selected.

3.14 Perbadanan TAIB reserves the right to replace the prizes with alternative prize of equal or higher value if circumstances beyond Perbadanan TAIB's control makes it necessary to do so.

3.15 Prizes must be collected in person or by an authorized representative. Authorised representative must present an authorisation letter from the Winner and the authorised representative's original identity card.

4. GENERAL

4.1. By participating in this Promotion, the Customer agrees to be bound by this Specific T&C.

4.2. Perbadanan TAIB reserves the right to extend, cancel, terminate, or suspend this Promotion at any time without assigning any reasons and without prior notice.

4.3. Perbadanan TAIB reserves the right to amend, add, vary or modify any provision in this Specific T&C at any time, and such modification, amendment, variation or addition shall be notified to the Customer.

4.4. The Customers shall accept the prizes on an 'as is where is' basis. Perbadanan TAIB makes

no representation or warranty whatsoever for any inherent defect/fault(s) with respect to the prizes.

- 4.5. Perbadanan TAIB shall not be liable to the Customers for any failure to receive notices due to including but not limited to spam, junk, other security settings or for any incorrect contact information.
- 4.6. In the event of any inconsistency between this Specific T&C and any brochure, marketing or material relating to this Promotion, this Specific T&C shall prevail.
- 4.7. Perbadanan TAIB's decision on any or all matters relating to this Specific T&C shall be final, conclusive, and binding and no correspondences, queries, appeals or attempts to dispute such decision shall be entertained.
- 4.8. By agreeing to this Specific T&C, the selected Customers hereby authorise Perbadanan TAIB and shall be entitled to use his names, pictures/photographs for publicity, advertising and/or commercial purposes.
- 4.9. Perbadanan TAIB may substitute prizes with similar value and at any time without prior notice and is not obliged to inform reasons thereof.

Perbadanan TAIB shall not be liable for any loss, damage or expenses arising out of or in connection with this Promotion or resulting from Perbadanan TAIB's non-performance due to natural disaster, war, riot, strike, lockout, industrial action, fire, storm, act of terrorism, technical or system failure or any event beyond Perbadanan TAIB's control.
- 4.11. For the avoidance of doubt, any extension, cancellation, termination or suspension of this Promotion, the Customer who is awarded from this Promotion shall not be entitled to any compensation or make any claim against Perbadanan TAIB.
- 4.12. This Specific T&C shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any dispute or claim arising herefrom.
- 4.13. This Promotion cannot be used in conjunction with other offers, promotions, and/or privileges unless otherwise stated.
- 4.14. The Customer is not allowed to assign any of their rights or obligations under this Promotion.
